The hours that the fair will be open for business are: Friday, September 7 – 4:00 pm to 10:00 pm; Saturday, September 8 – 9:00 am to 10:00 pm; and Sunday, September 9 9:00 am – 4:00pm.

Lessees must be set up and ready for business by 4:00 pm Friday afternoon and remain open until closing time each day.

Lessees must NOT solicit sales of lessee's products or services outside of their assigned space.

All food vendors must be licensed by Town of Halton Hills as a Commercial Refreshment Vehicle (CRV) and pay a license fee of \$100 per event. Non-for-profit groups, minor sport organizations and Food Businesses currently licensed with the Town of Halton Hills may be exempt from this fee.
